



Steps to Complete a PLUS Loan Credit Check (to be complete by the parent)

1. Go to studentaid.gov
2. Log in with the parent's FSA-ID & password. (Upper right corner)
3. At the top, choose **Loans and Grants** and then **PLUS Loans: Grad PLUS & Parent PLUS**.



4. Click **"Log In to Start"** to begin the process. Select Award Year your student will be attending the school & enter the student's data. (Pay special attention to the SS# and date of birth).



5. Choose your students school by entering North Carolina, and Chowan University.

 1. Proceed with the denial. The student is the eligible for additional loan funds in his/her name.
 2. Appeal the credit decision. Contact Direct Applicant Services (800-557-7394).
 3. Add an Endorser. Contact the Financial Aid Office (252-398-6513).
